- 4. The bidders will submit their tender documents as per the dates mentioned in the timing schedule. No bid will be entertained after expiry of time period as mentioned in schedule.
- 5. If the tender opening date happens to be a holiday the next working day will be considered as tender opening dates.
- 6. Dean, Pt JNM Medical College Raipur reserves the right to increase or decrease the number of buses at any stage.
- 7. Please indicate the name, designation and authentication of the person who signs the bid and who shall have further correspondence in this case.
- 8. Hand written tender document not acceptable. All cuttings/over writing in the tender should be attested by the tenderer under his/her signature and date, failing which bid will be rejected.

# Terms of Bus Contract-A

- 1. The firms should have a registered & well established agency/firm having sufficient numbers of buses with models for hiring by the Medical College.
- 2. It may be noted that the number of buses to be hired &the number of days of hiring may vary depending upon the actual requirement.
- 3. The firm/agency shall give official mailing address, phone & fax. No. to which all correspondences shall be made by the institute. Also, if address is changed, the same shall have to be immediately intimated to the institute.
- 4. There must be appropriate permit for the vehicle issued by the competent authority as passenger transport vehicle.
- 5. 'On College Duty' must be displayed on the back and front of the vehicle.
- 6. There must be a First-Aid Box and drinking water in the bus.
- 7. The seat belt, whenever applicable, must be fastened properly.
- 8. The Institute name and Telephone numbers must be displayed on the bus.
- 9. Every vehicle for carrying student must be driven by a driver, who has minimum 5 years of experience in driving in such category of vehicles, is well conversant with the traffic rules, well behaved and must not have any record of previous traffic offences and his police verification has been done.
- 10. There must be an attendant in every such vehicle to ensure safe travel of the student and render adequate assistance for safe embarking and dis-embarking of the students.
- 11. Any teacher may also travel in the bus to ensure the safety norms.
- 12. The hired bus should be painted yellow.
- 13. The bus should be fitted with speed governor.
- 14. The doors of the bus should be fitted with reliable locks.
- 15. There should be a fire extinguisher in every bus.
- 16. The buses should be in good condition.
- 17. The contractors will not change the drivers frequently. In case of any change, all the relevant documents i.e. License & other ID proofs will be deposited with the in charge.
- 18. There will be a regular checking of buses to ensure compliance with mandatory safety norms.
- 19. Emergency exits are mandatory on all buses. Each school buses shall have emergency door on the right side which shall be closed properly and shall be opened only in emergency
- 20. A driver who has been challenged more than twice in a year for offences like red light jumping, violation of lane, discipline or allowing unauthorized person to drive cannot be employed.
- 21. A driver who has been challenged even for the offence of over speeding, drunken driving and dangerous driving etc. cannot be employed.
- 22. The bus should have been passed by the transport authorities.
- 23. The registration and insurance of the buses should be proper.
- 24. In case, there is breakdown of any bus, the contractor will make alternative arrangements.
- 25. A bus will cover upto 100 kms daily i.e. per day.

- 26. Route chart and evening halt place will be decided by the institute concerned and kilometers will be counted from the place of halt.
- 27. The contract will be valid for one year. In case of unsatisfactory service, it could be terminated at any time.
- 28. In case the contractor/transporter wish to withdraw the engaged bus, he should give one month prior notice to the Institute.
- 29. The successful bidders have to deposite Rs.50,000/- as security money.
- 30. The transporter/contractor will submit the medical certificate regarding the physical fitness of the driver including the eye testing, every year.
- 31. The drivers of the school buses have to be dressed in a distinctive uniform with their names inscribed in it
- 32. The buses should be fitted with a GPS system approved by Automotive Research Association of India (ARAI) & CCTV cameras.
- 33. Buses can be checked any times and if bus will not found as per norms penalty of Rs.5000/- per day will be imposed by the institution.
- 34. Buses should be as per the directions and mandatory requirements of Chhattisgarh Motor Vehicle Rules, 1994 The buses provided should be mechanically sound(fitness certificate to this effect will be submitted at time of signing of contract) not more than 10 years old.
- 35. Valid fitness certificate under section 56 of the Motor Vehicles Act, 1988 (No. 59 of 1988) shall have to be obtained.
- 36. The bidders shall abide by all statutory requirements for running the hiring contract. The institution shall have no responsibility & no way be liable towards taxes, fees, cast of diesel/Petrol/Toll taxes/Mobile and salary to drivers, maintenance tec. Or any other charges payable in respect of running he bus hiring contract except the contract price.
