


1. Sealed tenders are invited for the supply of "**Refrigerated Vaccum Concentrator**" (as per the specification attached) for the Multidisciplinary Research Unit. This tender is invited from Original Equipment Manufacuterer /OEM / Authorized Dealer for supply of Equipments to MRU, Pt. Jawahar Lal Nehru Memorial Medical College, Raipur (CG) in the financial year 2025-26.
3. The tender form can be downloaded and obtained from the college website www.ptjnmcraipur.in
4. **Tender Application Fee**: An amount of Rs. 1,000/- (Rupees One Thousand Only) must be submitted as a non-refundable bank draft drawn in favor of "Dean, Pt. J.N.M. Memorial Medical College, Raipur, C.G." from any nationalized bank with tender document.
5. **Earnest Money Deposit (EMD)**: Every tender must be accompanied by a bank draft of Rs. 30,000/- (Rupees Thirty Thousand Only) from a nationalized bank, drawn in favor of "Dean, Pt. Jawahar Lal Nehru Memorial Medical College, Raipur, C.G.".
 - The EMD of the successful bidder will be refunded only after the completion of the equipment installation process.
 - The EMD of the remaining bidders will be refunded within 15 days after the completion of the tender period.
 - The final decision regarding the EMD shall be universally accepted as that of the Dean
6. **Turnover**: Only those companies should participate in the tender whose average turnover is atleast Rs 1.5 crore for the last three financial years.
7. **Tender Submission Format**-The tender must be submitted in four sealed envelopes at the College Office. Sealed Envelopes No. 1, 2, and 3 should be placed inside a larger Envelope No. 4, sealed, and clearly marked on the exterior of Envelope as "**Tender Documents for the Supply of Refrigerated Vaccum Concentrator for MRU**".

Envelope No. 4 (the outer envelope) will be opened first, followed by Envelopes No. 1, 2, and 3.

1. Envelope No. 1 (Containing Tender Application Fee DD, EMD)
2. Envelope No. 2 (Technical Bid) will only be opened after the receipt of the EMD and Application Fee bank drafts in Envelope No. 1.



3. Envelope No. 3 (Financial Bid) will only be opened for bidders who are found to be **technically eligible** after opening and scrutiny of the Technical Bid (Envelope No. 2).

5. The tender will be awarded to the lowest price bidder who will be termed as the successful bidder afterwards.

12. The Dean reserves the right to change the rules and conditions of the tender without assigning any reason.


General Clauses -




- 1 Brand New machine as per the specifications provided below with latest version/ upgradation and made of virgin materials. The bidder must provide the make , model and detailed specification of his/her equipment in the technical bid envelope
- 2 The bidder must be either the original manufacturer or authorized supplier of the original manufacturer for the particular instrument. **(The supporting documents related to authorization letter from Manufacturer/OEM must be provided by the bidder for technical evaluation.)**
- 3 The bidder will have to submit the copy of last three years of annual accounts with audit certificate by Chartered accountant and Income-tax return.
- 4 The bidder will have to perform demonstration of the equipment to the technical experts of the institute Pt. J.N.M. Medical College, Raipur as a part of technical evaluation. All the expenses of the demonstration will be born by the bidder. Not performing demonstration within the stipulated time period (within 15 days of opening of technical bid) or unsatisfactory results of the demonstration will disqualify the bidder in the technical bidding process and financial bid of the bidder will not be opened.
- 5 The bidder must have supplied the equipment to any Govt institute /institute of repute of india within last one year. The quoted prices of the basic equipment must not be more than the said supply (excluding the price of warranty , CMC and accessories). (please provide supporting document)
6. Warranty /will start after successful installation and handing over of machine in functioning condition .
7. During warranty and CMC period quality assurance of the machine will be done by company at no additional cost.
