"NOTICE INVITING TENDER FOR RATE CONTRACT OF PRINT JOURNALS"

1. **Pt. J.N.M. Medical College, Raipur (C.G.)** invites bids for Annual Subscription of Medical Print Journals for Central Library of Pt. J.N.M. Medical College, Raipur (C.G.) on yearly basis from reputed companies/firms/individuals etc. those are in the business for the last three years. Accordingly, sealed tenders are invited latest by 02/02/2024 up to 14:00 noon. Proposed list of Print Journals to be procured is attached with the tender document.
  2. Complete Tender Document may be obtained from the Purchase Section, Pt. J.N.M. Medical College, Raipur (C.G.) on all working days from 11.00 AM to 5.00 PM from 04.01.2024 to 01.02.2024 by depositing a Demand Draft for Rs 500.00 payable at Raipur and drawn in favor of "The Dean, Pt. J.N.M. Medical College, Raipur (C.G.). It can also be downloaded from the website of [www.ptjnmcrapur.in](http://www.ptjnmcrapur.in). The bidders using the tender form downloaded from the website shall enclose a Demand Draft for Rs. 500.00 payable at Raipur and Drawn in favor of "The Dean, Pt. J.N.M. Medical College, Raipur (C.G.)
  3. The interested Companies/Firms/Agencies may send their bid complete in all respect along with Earnest Money Deposit (EMD) of Rs. 20,000/- (Rupees Twenty Thousand Only) in the form of FD issued in favour of The Dean, Pt. J.N.M. Medical College, Raipur (C.G.), drawn on any scheduled bank payable at Raipur and other requisite documents to the under signed duly superscripted "Bid for Tender No. ~~314~~ before 14.00 Hrs on 02/02/2024. The bids received after this dead line shall not be entertained under any circumstances whatsoever.
- NOTE: The EMD and Tender Fee draft should be put in the envelope containing Technical Bid failing which the tender shall be rejected forthwith.**
4. The sealed envelopes are to be deposited in the tender box placed at the Inward Section, (Room No. 19 ) of Pt. J.N.M. Medical College, Raipur (C.G.), or may be sent through registered/speed post addressed to The Dean, Pt. J.N.M. Medical College, Raipur (C.G.), **Bids sent by COURIER will not be entertained.**
  5. Bids will be opened on 02/02/2024 at 15.00 hrs in the presence of bidders or their authorized representatives who wish to participate in the bidding process. If the opening date happens to be a closed day/holiday, the tender will be opened on the next working day.
  6. Any future clarification(s) and / or corrigendum(s) shall be communicated by The Dean through the website [www.ptjnmcrapur.in](http://www.ptjnmcrapur.in).
  7. The Dean, Pt. J.N.M. Medical College, Raipur (C.G.), reserves the right to amend or withdraw any of the terms and conditions contained in the Tender Document including quantity/amount of items to be supplied or to reject any or all tenders without giving any notice or assigning any reason. The decision of the Dean, Pt. J.N.M. Medical College, Raipur (C.G.), in this regard shall be final.



## GENERAL INSTRUCTIONS TO THE TENDER

1. **Manner of Submission of Tender:** The bidding should be done on two bid method viz. 1) Technical Bid & 2) Commercial / Price Bid. The bidders should ensure that the Technical bid complete in all respect and containing the required enclosures (attested Photocopy) is sealed in a separate envelop and the commercial bid sealed in a separate envelop & both the sealed envelopes are kept and sealed in a suitable size of envelop. All envelop will be address to The Dean, Pt. J.N.M. Medical College, Raipur (C.G.). The Sealed Technical bid Envelop of all bidders will be opened first. Only the Commercial bids of those who have furnished all the valid documents will be opened. In case, any bidder encloses the financial bid with in technical bid, the same shall be rejected summarily.
2. **Language:** The language of the Tender shall be in English.
3. The tender Document can be downloaded from the website of Pt. J.N.M. Medical College, Raipur (C.G.). i.e. [www.ptjnmraipur.in](http://www.ptjnmraipur.in). The Technical bid must accompany with the tender fee of Rs. 500/- in form of Demand Draft in favour of The Dean Pt. J.N.M. Medical College, Raipur (C.G.). The tender document fee is non-refundable, non-adjustable and non-transferable and is payable through a demand draft on any scheduled bank drawn in favour of the "The Dean Pt. J.N.M. Medical College, Raipur (C.G.).
4. The Tenders should be type written or hand written but there should not be any overwriting or cutting. Correction, if any, shall be made by neatly crossing out, initialing, dating and rewriting. **The name and signature of bidder's authorized person should appear on each page of the application. All pages of the tender document shall be numbered and submitted as a package along with forwarding letter on agency's letterhead.**
5. **Documents to Accompany Tender:** The Tenderer shall submit the Documents mentioned in the clause 14 of General Instructions to the Tender.
6. The Contracts concluded as a result of this Tender Inquiry shall be governed by the 'Terms & Conditions' and other relevant instructions as contained in this Tender Document.
7. Bidders are requested to enclose a copy of their valid certificate of PAN No., TAN No., GST Registration/ITR or any other document as requested by the Institute with their tender.
8. Tenders received without Tender Fee and EMD amount by way of F.D. in favour of "The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) will not be considered at all.
9. **Refund of Earnest Money Deposit:** The EMD submitted by unsuccessful bidders shall be returned to them without any interest whatsoever, within 15 to 90 days after conclusion of the contract with successful bidder. The EMD submitted by successful bidders shall be returned to them after the successful bidder deposits the performance security according to conditions stipulated in the bid document.
10. Bidders may note that if the date of tender opening given in this Tender Document is declared to be a gazette holiday, the tender shall be opened on the next working day at the same timing. In such an event the closing hours for receipt of tenders in Pt. J.N.M. Medical College, Raipur (C.G.) will stand automatically extended upto 14.00 hours of the next working day in the Government offices.



11. Late/delayed tenders received in Pt. J.N.M. Medical College, Raipur (C.G.) due to any reason whatsoever will not be accepted under any circumstances.
12. At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason, or decision, modify the terms & conditions of the tender document by a corrigendum displayed on the website of Pt. J.N.M. Medical College, Raipur (C.G.) ([www.ptjnmcraipur.in](http://www.ptjnmcraipur.in)). In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.
13. Tendering firms are at liberty to be present or authorize a representative to be present at the opening of the tender at the time and date as specified in the Schedule. **The name and address of the representative authorized to attend the opening of the tender on behalf of a tendering firm should be indicated in the tender. The representative so deputed should also bring with him a letter of authority from the firm for having been authorized to be present at the time of opening of tender. Only one representative per firm shall be permitted to attend the opening of the tender.** The name and address of permanent representative of the firm, if any, should also be indicated in the tender. Representatives of firms who have not submitted the tender or representatives not possessing authority letter from the bidders or outsiders shall not be allowed to attend the tender opening process.

#### 14. DOCUMENTS COMPRISING THE BID:

The bids prepared by the bidder shall comprise of (1) The Technical Bid and (2) Financial Bid:

**TECHNICAL BID:-** To qualify in the Technical bid the firm should have the minimum eligibility criteria; the firm in this regard should submit the following documents—

- (a) The Company must be registered firm in India and in business for the last 3 years or more.
- (b) The company must have minimum turnover of Rs. Three Crores for the financial year ending March 2023.
- (c) The Vendor must attach the proof of authorized distributor of the reputed medical publisher.
- (d) The bidders should be having the experience of supplying Print Journals to at least 5 Govt. Medical College/Hospital in the last 3 years. Enclose order copies for the same.
- (e) At least five customers' feedback forms stating be quality of work and over all feedback issued by any Govt. Medical Colleges/central government organizations.
- (f) The bidder should be a publisher registered in India or should be 100% subsidiary in India of parent company or agent/distributor of the publisher if any. Joint ventures are not accepted. He should have satisfactorily completed/under process of Print Journals subscription work as mentioned in the tender document during the last three years ending last day of the month March 2023.
- (g) The technical bid should be accompanied by FD for bid security of the amount equal to sum of EMD amount as mentioned in the Tender Document (refundable).



- (h) Copy of Income Tax Return Filed Acknowledgements for last Three years.
- (i) Copy of PAN Card.
- (j) Copy of GST Registration/ ITR certificate and return thereof for last three years.
- (k) The bidder must have adequate experience for supply/execution of similar work in Govt. Medical Colleges/central government organizations. Necessary supporting documents like work orders for last three years to this effect must be submitted along with the offer.
- (l) Price List of different Publishers must be attached with the technical bid. In order to arrive at the cost of Print Journals after discount this price list will be refereed by the institute.
- (m) Notarized Affidavit for non-conviction/blacklisting.
- (n) A Xerox copy of the letter of the Reserve Bank of India permitting you to deal with the foreign journals subscription.
- (o) Xerox copy of the following membership certificate to be enclosed
  - a. Good offices committee (GOC)
  - b. Federation of publishers and Book sellers Association of India

#### **FINANCIAL BID:-**

- A. The supplier should inform Maximum discount offered Journal wise (Annexure-7) as well as discount offered on Indian & Foreign Journals Separately as per the financial bid format.

#### **15. SUBMISSION OF BIDS**

**15.1 SEALING AND MARKING OF BIDS:** The bidder shall seal the Technical and Financial Bids in separate envelopes and keep them in a bigger sealed envelope. The Technical Bid shall bear the name "TECHNICAL BID OF Tender No. 314" on the envelope, while the Financial Bid shall bear the name "FINANCIAL BID of Tender No. 314" on the envelope for avoiding any mismatch.

**15.2** The bigger envelope containing technical and financial bids in separate envelopes shall be:

- (b) All the envelopes shall bear the Tender name, the tender number and the words 'DO NOT OPEN BEFORE' (due date & time).
- (c) The envelopes shall indicate the name and address of the bidders to enable the bid to be returned unopened incase it is declared 'late' or rejected.



- (d) Bids shall be delivered in person and shall be dropped in the tender box placed in the inward-outward section of the Pt. J.N.M. Medical College Raipur (C.G.) or shall be sent by Registered/Speed Post. Bids sent by COURIER will not be entertained. The Purchaser shall not be responsible if the bids are delivered elsewhere.
- (e) **Venue of Tender Opening:** Tender will be opened in the board room of the Pt. J.N.M. Medical College Raipur (C.G.) at 15.00 hrs.' on the due date. If due to administrative reason, the venue/ time of bid opening is changed, it will be displayed prominently on the notice board of the Institute as well as on the website of Pt. J.N.M. Medical College Raipur (C.G.)

#### 16. BID PRICES:

Consolidated (flat) discount for medical, print-Journals of both foreign and Indian publishers should be given on maximum retail price (MRP). Bidder quoting maximum discount will be selected for supply of Journals (Indian & Foreign) (As in Annexure-02)

#### 17 TECHNICAL EVALUATION:

- 17.1 Detailed technical evaluation shall be carried out by Technical Evaluation Committee pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and condition of the tender without any material deviation. The Institute's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The Institute shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order.
- 17.2 The technical evaluation committee may call the responsive bidders for discussion or presentation to facilitate and assess their understanding of the scope of work and its execution. However, the committee shall have sole discretion to call for discussion/presentation.
- 17.3 Financial bids of only those bidders who qualify the technical criteria will be opened, provided all other requirements are fulfilled.
- 17.4 A bid determined as substantially non-responsive will be rejected by the Institute and shall not subsequent to the bid opening be made responsive by the bidder by correction of the nonconformity.
- 17.5 The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) shall have right to accept or reject any or all tenders without assigning any reasons thereof.

#### 18 FINANCIAL EVALUATIONS AND COMPARISON OF SUBSTANTIALLY TECHNICAL RESPONSIVE BIDS:

- 18.1 The financial bid shall be opened of only those bidders who have been found to be technically eligible as enumerated under clause 15. The financial bids shall be opened in presence of representatives of technically eligible bidders, who may like to be present. The Institute shall in form the date, place and time for opening of financial bid.



18.2 The Financial Bids of unsuccessful bidders would not be opened and destroyed.

18.3 The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) does not bind herself to accept the lowest bid or any bid and reserves the right of accepting the whole or any part of the bid or portion of the job offered; and the bidder shall provide the same at the rates quoted. The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) reserves the right to reject any or all offers received in response to tender or cancel or withdraw the tender notice without assigning any reason, whatsoever.

## **19 AWARD OF CONTRACT: PLACEMENT OF ORDER**

The Purchaser shall consider placement of orders for commercial supplies on those bidders whose offers have been found technically, commercially and financially acceptable and whose goods type have been approved/ validated by the purchaser. The Purchaser reserves the right to counter offer price(s), against price(s) quoted by any bidder?

## **20 PERFORMANCE BANK GUARANTEE & EXECUTION OF CONTRACT:**

20.1 Firm whose offer is accepted will have to furnish Performance Bank Guarantee of an amount equal to 7% of the purchase order value, in favor of The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) issued by any scheduled bank.

20.2 The performance Bank Guarantee submitted should be valid for 1.5 years (18 months).

20.3 The Performance Bank Guarantee shall be refunded within 15 to 90 days after completion of the contract as per order, or after the expiry of contract on satisfactory completion of the same whichever is later.

20.4 No interest will be paid on Performance Bank Guarantee/Earnest Money Deposit.

20.5 In case of breach of any terms and conditions of the contract or on unsatisfactory performance, the amount of security deposit shall be liable forfeited by The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) and his decision shall be final.

20.6 The expenses of completing and stamping the agreement shall be paid by the bidder.



## **TERMS & CONDITIONS OF THE CONTRACT**

1. The firm/agency must have requisite trade and other licenses to do the business of Print Journals subscription for which the bid is being made.
2. **Earnest Money Deposit:** Each Tender must be accompanied with "Earnest Money Deposit" in the form of F.D., as mentioned in the Notice Inviting Tender.
3. **Forfeiture of Earnest Money:-**
  - a) If the Bidders withdraw their Bids after opening of the same or the successful bidders withdraw their Bids after approval of their rates.
  - b) If the successful bidders fails supply or refused either partial or total offer (Acceptance) made by The Dean, Pt. J.N.M. Medical College, Raipur (C.G.)
4. **Return of Earnest Money:-**
  - a) After finalization of the Tender, the deposited Earnest Money will be returned back to the unsuccessful bidders.
  - b) On receipt of Security Deposit, the deposited Earnest Money will be returned back to the successful Bidders.
5. **Deposition of Security Money:** - The Selected bidders must deposit the requisite amount of Security Money (100% of the approximate value of purchase order) within the stipulated date specified in the acceptance letter. The approved firm shall deposit the Security Money in the form of FD/Bank Guarantee payable at Raipur duly pledged in favour of The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) valid for 18 months.
6. **Forfeiture of Security Money:-**
  - a) In the event of failure to supply of Print Journals as per Work Order within the stipulated period, the security deposit may be forfeited.
  - b) In that event, supply of the said Journals may be taken from the next lowest bidder vide the same Work Order at contractors risk and cost without any further reference, so that the loss incurred would be recoverable from the Security Deposit of the said contractor or from any sum due of which may become due to the contractors.
  - c) If any Journal is damaged by the approved firm, cost of the same will be deducted from the deposited Security money of the contractor.
7. **Refund of Security Deposit-** After successful completion of entire supply Security Deposit will be refunded within the six months if not extended for further period.
8. **Submission of Documents:-**
  - a) Each Tender must accompany attested photocopy of Pan Card, Trade License, GST Registration Clearance Certificate/ITR Certificate, Registration Certificate, and Experience Certificate.



- b) The bidder must submit attested photocopy of IT, ITR etc. of last three years.
- c) In case of SSI/NSIC unit, current SSI/NSIC certificate must be deposited by the bidder along with his Tender which is issued in favor of the bidder for this type of jobs the bidder is exempted from submitting EMD & Tender Fee.

#### 9. Submission of the Tender:-

- a) Bidder at their own cost shall have to submit Tender at the office of The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) within the schedule date and time as mentioned in the Tender Notification No.
- b) The said sealed documental bids will be opened by the Tender Purchase Committee in presence of the Bidders or representative of the Bidders who may be present in the opening date & time.

#### 10. Discounts:-

- a) **Discounts** should be clearly quoted as per price bid format attached with the tender document.
- b) **Discounts should be quoted for all Print Journals.**

11. In the event of the tender being submitted by a firm, it must be signed separately by each member thereof, or in the event of absence of any partners, it must be signed on his behalf by a person holding "Power of Attorney" authorizing him to do so. Such "Power of Attorney" is to be produced with the Tender and in the case of the firm, carried on by one member of Joint Family, it must be disclosed that the firm is duly registered under the 'Indian Partnership Act'.

12. Necessary proof as to the financial status of the individual and firm tendering is to be attested and submitted.

13. Tender Form with all the relevant papers in details shall be essential part of the Tender.

14. Before submission of the Tender, the bidder shall sign each page of his Tender and all of its relevant papers with date. The additional alternative and or subtractive clause (if any) shall also to be signed by the bidder.

15. **Delivery:** Delivery period for all item will be 42 days from the date of issue of supply order. At least 90% of ordered quantity must be supplied by the vendor.

16. **Service Charges:** The supplier should inform whether any service charges are applicable on journal subscription services.

17. **Existing Customer List:** The supplier should enclose list of college. Universities, Govt. Institutions served by the supplier for journal subscription services or other customers of National repute.

18. The number of journals to be for the calendar year January to December which may increase or decrease at any stage of the contract by Pt. J.N.M. Medical College, Raipur (C.G.).



## 19. Liquidated Damage:

- a) In the event of the Supplier's failure to submit the Bonds, Guarantees and Documents, supply the article, etc. as specified in this contract, the Buyer may at his discretion, with hold any payment until the completion of the contract. The Buyer may also deduct from the Seller as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered, stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.
- b) At least 90% of ordered quantity must be supplied by the vendor failing which the same percentage of amount will be deducted from the bill value by which percentage of supplied quantity falls short. Amount deducted will only be paid to the vendor on completion of at least 90% supply.
- c) The Supply of the Journals shall be made by the registered post or through any of the courier services. This shall be made within 6 weeks of their publications. The dead line (Weekly/Monthly/Bi-monthly/Quarterly/Annual/bi-annual/etc.) of supply of the journals will be calculated on the basis of calendar week/month/quarter/year of publication of the concerned issue of the journal. Fine/Penalty @ 2% per month, per issue.
- d) That in the event of loss or non receipt of any copy/copies of the periodicals during transit, intimation of that will be given by the College to the supplier and on the receipt of such information the Supplier will supply all such issue without any extra charge within 6 weeks of receiving the information to the College.
- e) That the Supplier shall refund the full amount of subscription of Periodical which has not been received by the College during the said period of 6 weeks; failing which the amount of interest & @ 18% per annum shall be added to the principal amount.

**20. Warranty:-**The Journals should be good latest edition and original copy published by the publisher (not pirated).

## 21. Subscription:

- a. Selected Agent/Vendor upon receipt of confirm order shall process Institution subscription and make advance payment to respective publisher on behalf Pt. J.N.M. Medical College, Raipur (C.G.), library for the journals as per order. The Agent/Vendor shall submit their invoice within 15 days from the date of order along with price proof of publisher, copy of the draft remittance and subscription Name, Number and Date, from the publisher.
- b. For all periodical the supplier shall charge the publisher current subscription rate as interacted in the publisher current catalogues or invoices. Wherever concessional/package rate are available the supplier must charge accordingly.
- c. Rate quoted should include all taxes.
- d. The foreign journals available in dual currency should be billed in the currency by which the converted cost is the lowest in Indian rupees.



### **Subscription Period.**

**(A)** All journals are to be supplied for the calendar year 2024 or a complete volume as specified in the order.

Supply of the periodical should commence from the Issue No .1 of the volume starting during the year unless specified otherwise.

**Conversion Rates:** The current bank exchange rate applicable as submitted in the Financial Bid shall be used for conversion of foreign current supported by a certificate issued by a bank and counter signed by the supplier.

**22. Term of Payment:** - (22.1) The payment for the subscription of the periodicals if needed in advance, the firm has to give a proof of payment to the publisher through a scheduled bank, for the amount paid in advance to publisher. This document has to given by the firm to institute after the placement of "the purchase order, however before the release of Payment to the firm by the institute.

(22.2) The amount will only be reimbursed after the receipt of proof of purchase of Bank Drafts in favour of concerned publishers of the journals duly authenticated by the concerned Indian Bank/Foreign Bank's DO/Cheque (photo copy) on behalf of Pt. J.N.M. Medical College, Raipur (C.G.)

(22.3) Subscription price of each journal must be publisher's price and should be indicated in original currency and converted to rupee in accordance with the GOC norms.

**a) On delivery:-** 90% payment of the contract price shall be paid on receipt of proof of subscription submission of the following documents:

- i) Four copies of supplier's invoice showing contract number, goods description, quantity, unit price and total amount;
- ii) Consignee Receipt Certificate in original issued by the authorized representative of the consignee;
- iii) Two copies of packing list identifying contents of each package;
- iv) Affidavit stating that all the Print Journals supplied are of latest edition and original (not pirated).
- v) Inspection certificate issued by the nominated person/committee/agency, if any.

**b) On Acceptance: -**

Balance 10% payment would be made against 'Final Acceptance Certificate' of goods to be issued by the consignee subject to recoveries, if any, either on account of non-rectification of defects/deficiencies not attended by the Supplier or otherwise. Or 100% after acceptance of goods along with the documents quoted above.

**23. Validity of Price:** - Minimum up to one year from date of tender submission and it should be extendable.

- a) Acceptance of highest quoted discount is not obligatory.
- 



- b) The Dean, Pt. J.N.M. Medical College, Raipur (C.G.) reserves all rights to accept or reject any Tender without showing any reason.
- c) The Tender, submitted by the firm who have already been declared as Black Listed or whose contract was terminated for dissatisfactory supply.
- d) Submission of the Tender by a bidder shall be taken to signify his acceptance of the above terms and conditions. Alterations, overwriting or erasures of any terms and conditions are not permitted.
- e) Canvassing in any form is strictly prohibited and the bidders who are found Canvassing are liable to have their tenders rejected out rightly.
- f) Penalties for non-performance: The penalties to be imposed, at any stage, under this tender are;
  - i) Imposition of liquidated damages,
  - ii) Forfeiture of EMD/performance security,
  - iii) Termination of the contract,
  - iv) Blacklisting/debarring of the bidder

**24. Period of Contract:** The consolidated (Flat) discounts offered by the bidder must be valid for the period of one year from the date of award/signing the contract. The period of contract may be extended by the institute bases on satisfactory performance of the bidder on mutual consent.

## **25. Termination of Contract**
